In consideration of renting and operating a go-kart at COMPETITION RACING, Inc., I hereby release COMPETITION RACING, Inc., an Indiana incorporated company, d/b/a COMPETITION RACING, its agents, employees, landlord, successors and assigns, from any and all liability, claims, demands, actions, and causes of action whatsoever, whether foreseen or unforeseen, arising out of or related in any way to my renting and operating a go-kart at COMPETITION RACING, Inc. that may result in injury, death or property damage or loss or other damages to me or my family, estate, heirs, or assigns and further to save and hold harmless COMPETITION RACING, Inc. its members, agents, employees, landlord, successors, or assigns, from all liability whatsoever for personal injury, property damages, or loss or wrongful death caused by its negligence. I understand that this activity is dangerous and may become more hazardous during the time that I am on the premises of COMPETITION RACING, Inc.; that the risk of injury from the operation of a go-kart is significant, including the potential for serious bodily injury, paralysis and death; that I am aware of all the risks and hazards inherent with my operating a go-kart at COMPETITION RACING, Inc. and hereby voluntarily assume all risks of loss, damage and injury, including death, that may be sustained by me or any property of mine while at COMPETITION RACING, Inc.. This release shall be binding upon me, my family, estate, heirs, or assigns. This release shall continue in effect each time I rent and operate a go-kart at COMPETITION RACING, Inc...In signing the foregoing Liability Release, I acknowledge and represent: a) That I have read the foregoing Liability Release, I understand it, and sign voluntarily; b) That I am at least 56 inches tall 10 years old and I have a parent or guardian present to sign for responsibility for my actions; c) That I am not pregnant; d) That I have not consumed alcohol or drugs which may affect my ability to drive a kart in a safe manner, and no refund will be given if proven otherwise; e) That I do not suffer from a heart condition, high blood pressure, or other medical conditions which may be aggravated by my operating a go-kart; f) That I will wear a helmet while operating a go-kart or otherwise while in or around the race track and will be liable to any helmet damage I incur; g) That I have taken notice of and will obey all rules and regulations of COMPETITION RACING, Inc.; h) That I must follow the briefing in order to operate a go-kart; i) That if I have any questions I will ask a qualified COMPETITION RACING, Inc. official for further instructions, and will not operate a go-kart until I fully understand the instructions and policies. j) That I will not operate the go-kart using the brake and gas-throttle at the same time since this can cause serious damage and I will be liable for such damage.
